**USE ON STAINLESS STEEL EQUIPMENT, IRRIGATION LINES,  
GREENHOUSE SURFACES, CONVEYORS, VATS AND PIPING SYSTEMS.**

GreenClean Acid Cleaner is a blend of mineral acid with wetting agents that quickly works on organic deposits, calcium and other hard water mineral deposits, alkaline/caustic buildup, and rust.

**USES:** Use on equipment in all types of food production facilities, dairy, beverage, poultry, agricultural, horticultural and other general industries wherever scale, oxide or lime build up is a problem. Use to remove whitewash from greenhouse glass. Can be used for neutralization of alkalinity in hoses, lines and cleaners. May be sprayed, circulated or used in soak tanks. **Not recommended for use on soft metals and painted surfaces.**

**SURFACE CLEANING DIRECTIONS FOR USE:** Dilute 3–8 fl. oz. of GreenClean Acid Cleaner per gallon of clean water. Allow to dwell for 10-15 minutes followed with a clean water rinse using a pressure washer or hose sprayer. Higher rates are recommended for heavily soiled surfaces. After rinsing, use SaniDate 5.0 Sanitizer/Disinfectant according to label directions to disinfect hard surfaces and equipment.

**IRRIGATION LINE CLEANING DIRECTION FOR USE:** Make GreenClean Acid Cleaner application between crops or when crops are not present. Set injector at 1:50 and inject concentrated GreenClean Acid Cleaner until irrigation lines are at or near capacity. Allow to sit for up to eight hours. Flush lines with clean water until pH returns to neutral. Use GreenClean Acid Cleaner prior to or in conjunction with SaniDate 5.0 Sanitizer/Disinfectant as part of BioSafe Systems' complete line cleaning program.

**Additional Precautions:** Avoid contact with skin, eyes and clothing and wear safety glasses and protective clothing when handling GreenClean Acid Cleaner. Do not mix with other chemicals. Avoid contact with pH and conductivity electrodes. Avoid contact with plant material and delicate surfaces. Do not allow GreenClean Acid Cleaner solution to dry and rinse with water immediately after recommended contact time.
