4. First-Aid Measures

Description of first aid measures

5. Fire-Fighting Measures

Extinguishing media

Suitable extinguishing media: water spray, carbon dioxide, foam, dry powder

Hazards during fire-fighting:

6. Accidental release measures

Methods and material for containment and cleaning up

7. Handling and Storage
