**Use Sites/Pests:** Controls moss, algae, lichens & liverworts in, and around nurseries and greenhouses, and on and around buildings. Can be used on lawns, turf (including golf courses, lawn bowling greens, parks, playgrounds, cemeteries, athletic fields and office and industrial parks), cultivated areas, roofs, decks, siding, walkways, fences, growing containers, other structural surfaces, hardened bark of trees and exteriors of motor homes & boats.

## **DIRECTIONS FOR USE:**

### **APPLICATION DIRECTIONS**

Test spray a small area prior to using. If moss is dry, thoroughly wet moss with water before treating.

#### **Greenhouse**

Dilute concentrate by mixing one part concentrate with 9 to 19 parts water (put 50 to 100mL in 1 litre of water). Apply 300-500 mL/m<sup>2</sup>. For thick moss (greater than 2.5 cm), apply 1 L/m<sup>2</sup>. If moss is dry, thoroughly wet moss with water before treating. Repeat treatment when new moss or algae are visible.

#### **Nurseries**

Dilute concentrate by mixing one part concentrate with 9 to 19 parts water (put 50 to 100mL in 1 litre of water). Apply 300-500 mL/m<sup>2</sup>. For thick moss (greater than 2.5 cm), apply 1 L/m<sup>2</sup>. If moss is dry, thoroughly wet moss with water before treating. Repeat treatment when new moss or algae are visible.

**Golf Courses:** Dilute concentrate by mixing one part concentrate with 19 parts water (50 mL/ 1 litre water). For putting greens, fairways and other areas apply 500-1000 mL/m<sup>2</sup> ( 5000 litres/hectare).

**Motor Homes and Boats:** Dilute product by mixing one part product with 19 parts water (50 mL/1 litre water). Wear gloves during application. Use on outside surfaces only. Spray thoroughly with MOSS-ASIDE Moss Killer. Scrub surfaces thoroughly with a brush after application, then rinse with water. Repeat as necessary.

**Parks and Playgrounds:** Dilute concentrate by mixing one part concentrate with 19 parts water (50 mL/ 1 litre water). Thoroughly soak moss with solution, applying 500-1000 mL/m<sup>2</sup> ( 5000 litres/hectare). For thick moss (greater than 2.5 cm), use up to 2 L/m<sup>2</sup>.

**Lawns, Turf and Cultivated Areas:** Dilute concentrate by mixing one part concentrate with 19 parts water (50 mL/ 1 litre water). Thoroughly soak moss with solution, applying 500-1000 mL/m<sup>2</sup> ( 5000 litres/hectare). For thick moss (greater than 2.5 cm), use up to 2 L/m<sup>2</sup>. Avoid overlapping spray to eliminate risk of damage to turf grasses and ornamentals.

**Follow-Up on Golf Courses, Parks, Playgrounds, Lawns, Turf, and Ornamental Gardens:**

Lightly rinse treated areas with water (50 mL/m<sup>2</sup> or less) 15 to 30 minutes after treatment to avoid grass/turf damage. Do not heavily irrigate for at least 6 hours after treatment. Re-apply every 2 weeks or as required. If it rains within one day of treatment, an additional application may be required. Moss will turn brown after a few days. People and pets can enter the treated area after spray has dried. Areas can be re-sown 5 days after treatment.

**Other Sites:** Dilute concentrate by mixing one part concentrate with 9 to 15 parts water (put 63 to 100mL in 1 litre of water). Apply 300-500 mL/m<sup>2</sup>. For thick moss (greater than 2.5 cm), apply 1 L/m<sup>2</sup>. If moss is dry, thoroughly wet moss with water before treating. Repeat treatment annually, or when new moss or algae are visible.

**WHEN TO USE:** Use at any time during the year. Best results are obtained with actively growing moss in the spring or fall. Do not use on lawns when temperature exceeds 30°C. During warmer weather apply late in the day. Application during cold weather may delay appearance of moss control.

**METHODS OF APPLICATION:** Apply with standard spray equipment. Keep sprayer moving to get an even application. In areas of hard water, use water softeners.

**APPLICATION RESTRICTIONS**

Do not use with spreaders or stickers.

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN.

Causes eye and/or skin irritation. DO NOT get in eyes or on skin and clothing. Use only in well ventilated areas. Wear long sleeved shirt and long pants, chemical resistant gloves, shoes, and goggles or face shield during mixing, loading, clean up and repair. Wear long sleeved shirt and long pants during application. Remove contaminated clothing and wash before reuse. Freshly treated areas may be slippery. If spilled, use absorbent materials and dispose of soiled materials in an approved manner as described in the Disposal section of this label. Do not store at temperatures below 0°C.

**TOXICOLOGICAL INFORMATION:**

Treat Symptomatically.

**FIRST AID:**

**IF SWALLOWED:** Call poison control centre or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**DISPOSAL:**

1. Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
