SECTION 5: FIRE FIGHTING MEASURES

Suitable (and Unsuitable) Extinguishing Media: Use foam, carbon dioxide, dry powder or halon extinguishant. DO NOT USE WATER.

Specific Hazards Arising from the Product: Spontaneous combustion may occur at high temperatures or when exposed to water. Conditions for Safe Storage, Including Any Incompatibilities: Store RIDOMIL GOLD MZ 68WG in a dry, well ventilated area. Ideally, store the product at temperatures below 30 °C, but never expose this material to temperatures in excess of 50 °C. Do not allow RIDOMIL GOLD MZ 68WG to become wet or over-heated as decomposition may result. Decomposition produces a foul odour due the formation of toxic, flammable gases. Remove wet/damp or hot containers immediately to an open area for disposal. Dense packing of bags may lead to decomposition. Store bags on pallets no more than 3 high. Loose bags should not be stacked more than 2x2x2 m. This product is combustible, protect from heat, sparks, open flames and other sources of ignition.
