Emergency and First Aid Procedures

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Skin contact: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

Ingestion: Call a physician or Poison Control Center. Drink one or two glasses of water and induce vomiting by touching back of throat with finger, or if available, by administering syrup of ipecac. If syrup of ipecac is available, administer 1 table spoonful (15 mL) of syrup of ipecac followed by 1 to 2 glasses of water. If vomiting does not occur within 20 minutes, repeat the dose once. Do not induce vomiting or give anything by mouth to an unconscious person.

Inhalation: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.

Call a poison control center or doctor for treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-267-1373 for emergency medical treatment information.

Notes to physicians

There is no specific antidote. All treatment should be based on observed signs and symptoms of distress in the patient. Overexposure to materials other than this product may have occurred.

Section VII - Precautions for Safe Handling and Use

Steps to Be Taken in Case Material is Released or Spilled

Safeguards

NOTE: Review FIRE FIGHTING MEASURES and HANDLING (PERSONNEL) section before proceeding with clean-up

Use appropriate PERSONAL PROTECTIVE EQUIPMENT during clean up.

Evacuate personnel. Wear self-contained breathing apparatus (SCBA) and full protective gear. Emergency Response – Chemical resistant coveralls, waterproof gloves, waterproof boots and face/eye protection.

If dusting occurs, use NIOSH approved respirator protection. (Respirator with a NIOSH/MSHA/BHSE-approved organic vapour-removing cartridge with a pre-filter approved for pesticides or a NIOSH/MSHA/BHSE-approved canister approved for pesticides during application.

Evacuation Procedures and Safety: Personnel handling the material should be thoroughly trained to handle spills and releases. Wear appropriate gear for the situation.

Initial Containment

Dike spill. Prevent material from entering sewers, waterways, or low areas. Dike spill with earth or sand. Follow applicable Federal, State/Provincial and Local laws/ regulations. Containment of spill: Stop leak if it can be done without risk. Follow procedure under Clean up and Disposal of spill.

Spill clean up

Refer to Section WI for personal protective equipment in handling.

Avoid causing dust. Shovel, vacuum or scoop up to a metal drum for disposal.

All flushing and clean-up residuals should be collected for proper disposal to prevent soil and surface, ground and sewer water contamination. Do not allow to contaminate ground or surface water system.

Clean-up and disposal of Spill:

Sweep up and place in an appropriate closed container.

No sparking tools should be used.

Avoid creation of dusty conditions. Clean up residual material by washing area with water and detergent. Collect washing for disposal. Decontaminate tools and equipment following clean up.

Accidental Release Measures

Environmental and Regulatory Reporting: Do not flush to drain. If spilled on the ground the affected area should be scraped clean and placed in an appropriate container for disposal. Prevent material from entering public sewer system or any waterways. Report any spills to CANUTEC (1-800-424-9300).

Disposal Method

Waste Disposal

Do not contaminate water supply, food or feed by storage or disposal.

Do not dispose of by open dumping. Do not flush to surface water or sanitary sewer system. Do not contaminate water, food or feed by disposal. Contamination with this product will render water, food, or feed unfit for human or animal consumption. Wastes resulting from use of this product may be disposed of on site or at an approved waste disposal facility. Chemical additions, processing or otherwise altering his material may make the waste management information presented in this MSDS incomplete, inaccurate or otherwise different from federal laws and regulations. Container Disposal

Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. If burned, stay out of smoke.

Precautions to Be Taken in Handling and Storing

Handling (Personnel)

Avoid contact with eyes, skin or clothing. Avoid breathing vapors or mist.

Avoid breathing dust. Wash thoroughly after handling

Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.

Keep out of reach of children and animals.

Personnel handling this product should be thoroughly trained as to its hazards.

Use non-sparking tools and grounded/bonded equipment and containers when transferring. Do not ingest. Do not breathe dust or mists.

Avoid getting material on clothing. Use handling, storage and disposal procedures that will prevent contamination of water, food or feed.

Personal hygiene is an important work practice exposure control measure and the following general measures should be taken when working with or handling this material:

Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment (PPE) immediately after handling this product.

Wash the outside of gloves before removing.

Handling (Physical aspects)

This product may present a dust explosion hazard.

Dry powders can build static electricity charges when subjected to the friction of conveying, mixing or sliding.

Provide adequate precautions, such as electrical grounding, or inert atmospheres when material is used in the presence of flammable materials to prevent ignition.

It is recommended that all dust control equipment and material transport system involved in handling of this product contain explosion relief vents or explosion suppression system or an oxygen deficient environment. In addition, all conductive elements of the system that contact this material should be electrically bonded and grounded. This powder should not be flowed through non-conductive ducts or pipes. Use only appropriately classed electrical equipment.

Storage

Store product in original container only. Do not contaminate water, other pesticides, fertilizer, food or feed in storage.

Store in a cool dry place. Keep away from heat, sparks and flames.

Do not store in or around the home. Store unused product in a cool, ventilated, dry locked area.

Never transfer this product to another container for storage. Do not allow prolonged storage in areas where temperatures frequently exceed 115F (46°C).
